Minutes: January 15, 2019 Membership Meeting.

- Topics discussed in detail were skirting and siding, window replacement, adding a shed (e.g. Rubbermaid) or screen room under a carport, code violation process, typical permit process steps for replacement/rebuilding/new construction of outside structures, permits for interior remodeling if, say, the structure is being modified or components such as a toilet being relocated, zoning codes, replacement of existing or damaged homes, support columns and (under) drainage requirements for new homes, movement of existing homes regardless of age, demo-permits to tear down an existing home, and driveway extensions/expansions.
- Further clarification of an explanation on any of the above or additional questions that were not brought up should be addressed to either of the presenters.
- Specific questions on permitting not addressed can be forwarded to Permit Manager Jennifer Hardin.
